I. Call to Order and Record of Attendance

Ms. Anne Clutterbuck, Chair, called the meeting to order at 8:30 a.m., and noted that a quorum was present. The attendance was recorded.

II. Approval of the Minutes of the Previous Meeting

Moved by Dr. Kimberly Monday, seconded by Ms. Linda Morales, and unanimously passed that the Board approve the minutes of the November 18, 2019 and December 12, 2019 Special Called Board of Trustees meetings.

IV. Public Comments / Hear From Citizens

V. Approval of the Harris Health System FY2021 Operating and Capital Budget

Mr. Michael Norby, Executive Vice President & Chief Financial Officer, stated that there were minor edits to the budget projections for year 2021. He reported an increase in net patient service revenue of approximately \$4M to \$5M. He also reported a market adjustment of \$4M for nursing salary and wages. Mr. Norby noted that the capital budget summary was updated to recognize the issuance of certificate of obligations of \$36M for the implementation of EPIC at the Harris Center and Harris County Jail facilities. He reported an additional \$10M for Ben Taub Hospital (BTH) emergency room renovations and \$10M for Harris County Hospital District Foundation for a total capital budget of \$121.8M. Mr. Norby stated that Harris Health is still on target to achieve a 1% operating margin for next year. He announced that the public hearing for the FY2021 operating and capital budget will be held on January 23, 2020 and a presentation at Commissioners Court is scheduled for January 28, 2020.

Motion 20.01-03

Moved by Dr. Ewan Johnson, seconded by Dr. Arthur Bracey, and unanimously passed that the Board accept agenda item VI.

VI. Approval to Appoint Ms. Tracey Burdine as Director of Harris Health System's Health Care for the Homeless Program as Required by the Health Resources and Services Administration in Accordance with 42 CFR \$51c.304(d)(3)(i).

Dr. Jennifer Small, Vice President & Associate Administrator, Ambulatory Care Services, presented Ms. Tracey Burdine to the Board of Trustees.
