Ms. Clutterbuck stated that Dr. Porsa will be introduced to the community during the Board of Trustees' meeting on December 5, 2019. Additionally, Ms. Clutterbuck thanked the CEO Search Committee members for their time and efforts during this lengthy and thoughtful search process.
