1. General Anchor Communication

2. DSRIP Implementation

DY9R2 (October) Reporting

- October DY9 reporting materials will be posted on the DSRIP Online Reporting System's bulletin board starting at the end of September, as they are finalized.

Category C Summary Workbook

- By Monday, 9/21/20, the DSRIP team will post the updated version of the Category C Summary Workbook to the Online Reporting System bulletin board. Providers should review the workbook and confirm that all updates are as expected. If providers find any data discrepancies in the Category C Summary Workbook, they should contact the waiver inbox by **EOD Monday, 9/28/20**. Please include provider TPI and Measure ID in all communications about specific measures.
- The DSRIP team has been working with providers to resolve their Technical Assistance flags from April DY9R1 reporting since June. Thank you for your thorough attention to the TA process. Not all TA flags have yet been resolved; however, most TA flags resolved before 9/17/20 should be included in the updates. Additionally, providers should expect to see results from Myers & Stauffer round 1a in the updated Workbook. Providers will not find round 1b results in the Summary Workbook yet.

Compliance Monitoring Update: MSLC is in the process of completing round 1b reviews. There are 55 outstanding measures that MSLC continues to work with providers on and they aim to complete those reviews by September 30th. No additional deadline extensions will be allowed. If providers do not comply with requests for documentation, achievement funds associated with the measures may be recouped. This may also result in additional audit requests for other Category C measures.

Providers that have received their round 1a and 1b audit results for baseline and PY1 should review their previously reported PY2 data and resubmit the data in October to ensure consistent reporting methodology across baseline and performance years.

3. DSRIP Transition

DY11 Options: HHSC is working with Provider Finance (formerly known as Rate Analysis/RAD) on changes to UHRIP and NAIP to incorporate DSRIP Transition for hospitals and physician practices for DY11. These are exploratory workgroups to develop concepts for DPPs that include quality components. If the workgroups come to consensus on how to move forward, then there will be additional opportunities for stakeholder feedback. HHSC continues to work on other DY11 options and broader proposals for DY12 transition.

The UHRIP workgroup includes representatives from hospital associations (THA, THOT, CHAT, TAVH, TORCH, TEHP) and from each UHRIP hospital class (children’s, non-urban public, rural private, rural public, state-owned, urban public, IMD, other). The physician workgroup includes representatives from each of the DSRIP physician practices affiliated with an academic health science center; system-wide representatives for UT, Texas A&M, and Texas Tech; representatives from THA and THOT; and clinical representatives from TMA.

Best Practices Workgroup: *Survey 3: Stratifying MLIU Population Data and Exploring Organizational Factors* closed on September 9, 2020 with a survey response rate of 62% (52/84 members). HHSC will analyze the survey responses and share the final results tentatively by the end of September.

Provider Survey: *HHSC M-7 Survey of DSRIP Providers on Alternative Payment Models* was extended and closes on September 28, 2020. This survey will collect provider feedback on the opportunities and challenges regarding contracting with Medicaid MCOs using alternative payment models. Please communicate this extension to your providers and encourage their participation.
