**Baylor College** of Medicine



The project highlighted below is the Baylor College of Medicine Teen Health Clinic (BTHC). The project provides primary care, reproductive, and psycho-social services to low income adolescents between the ages of 13-24. As a result of establishing this teen clinic, Baylor College of Medicine has increased access to primary care and

reproduction services which aligns with our Region 3 goals. In 2013, Baylor College of Medicine Teen Health Clinic (BTHC) had nine locations throughout inner city Houston. BTHC offers accessible, ageappropriate, comprehensive primary care and reproductive health services to adolescents and young adults living in inner-city Houston, where economic and health disparities are the greatest. Its services include family planning, screening and treatment for STI and HIV, mental health screening, immunization, health risk reduction education, prenatal care, sports physicals, wellness exams, nutrition services, counseling and case management.

# Do You Tableau?

This month, HHSC released the Tableau Dashboard, a new interactive tool that enables anyone to search active DSIRP projects by RHP, Provider Name, Provider Type, Project Option, Primary Project Type, and Category 3 Outcome for the entire state of Texas. Tableau is a business intelligence tool that is used across more than twenty diverse industries including banking, aerospace, and insurance. The dashboard presents Category 1-3 data in a variety of user-friendly summaries and graphs. Tableau is designed so that people of any skill level can use the tool to analyze real-time data, draw insights, and share information quickly and efficiently. Data graphs and summaries from Tableau can be shared via email, web conference, and can also be downloaded in an excel format. Category 3 baselines are being audited now and are expected to last through the end of September 2015. Myers and Stauffer will contact providers directly when a baseline has been selected for review. Please communicate directly with Myer and Stauffer in a timely manner to help ensure the process moves efficiently. We understand the review process is new for providers and as your Anchor team we are always here to help. In DSRIP, it pays to be proactive. Check baselines internally as this helps ensure the information being reported each period is accurate and that it can be validated.
