TITLE:	SMOKE-FREE, TOBACCO-F ENVIRONMENT	REE AND	VAPE-FREE
PURPOSE:	To provide guidelines for maintaining the Harris Health System as a smoke-free, tobacco-free and vape-free environment.		

POLICY STATEMENT:

The Harris Health System (Harris Health) provides a healthy, smoke-free, tobacco-free and vape-free environment for all workforce members of Harris Health. Harris Health designates its facilities as "smoke-free, tobacco-free and vape-free."

I. DEFINITIONS:

- A. **FACILITIES:** All health care facilities and other buildings owned or under control of Harris Health. These facilities include all hospitals, community health centers, eligibility centers, mobile health clinics, parking lots, and parking garages, and common areas on the premises. Common areas include elevators, lobbies, hallways, restrooms, reception areas, stairwells, seating areas, concourses, sidewalks, and walkways on the premises.
- B. **ELECTRONIC CIGARETTE/E-CIGARETTE:** Any electrical devise that simulates the act of tobacco smoking including e-cigarettes, e-cigars, e-hookahs and e-pipes.
- C. **SMOKING AND USING TOBACCO:** Includes utilizing chewing tobacco or the carrying of a lighted cigarette, cigar, pipe, or use of electronic nicotine delivery systems known as e-cigarettes, e-cigars, e-hookahs and e-pipes.
- D. **VAPING:** Vaping refers to the use of electronic nicotine delivery systems or electronic smoking devices. These are commonly called e-cigarettes, e-pipes, e-hookahs and e-cigars.
- E. **WORKFORCE MEMBERS:** Includes Harris Health System employees, contractors, and medical staff partners who work at Harris Health System facilities.

II. SMOKE FREE, TOBACCO-FREE AND VAPE-FREE ENVIRONMENT:

- A. Harris Health prohibits smoking and the use of all tobacco products in all Harris Health facilities and common areas.
- B. Harris Health prohibits the use of electronic nicotine delivery systems or electronic smoking devices. These are commonly called e-cigarettes, e-pipes, e-hookahs and e-cigars in all Harris Health facilities and common areas.
- C. Harris Health prohibits vaping in all Harris Health facilities and common areas. Vaping refers to the use of electronic nicotine delivery systems or electronic smoking devices. These are commonly called e-cigarettes, e-pipes, e-hookahs and e-cigars.
- D. Smoking and the use of tobacco products in any Harris Health vehicle or any personal vehicle while at any Harris Health facility is prohibited.
- E. Vaping or utilization of electronic nicotine delivery systems or electronic smoking devices such as e-cigarettes, e-pipes, e-hookahs and e-cigars in any Harris Health vehicle or any personal vehicle while at any Harris Health facility is prohibited.

III. SIGNAGE:

"No Smoking or Vaping" signs must be clearly posted at all prominent areas of Harris Health, including outdoor areas, parking lots, and garages.

IV. COMPLIANCE:

- A. All Harris Health workforce members.
- B. All non-compliant employees are subject to disciplinary action outlined in Harris Health System Policy and Procedures 6.20 Corrective Action.

- C. All Harris Health employees must inform a person smoking, vaping or using chewing tobacco in or on Harris Health facilities that smoking, vaping and the use of tobacco products is prohibited.
- D. Harris Health employees should inform the person that the facilities are smokefree, tobacco-free and vape-free. Upon providing this information to a person smoking, vaping or utilizing tobacco products, the Harris Health Employee should:
 - 1. Walk away from the person;
 - 2. Do not be confrontational; and
 - 3. If the person acts in a threatening manner contact the Security and Parking Department.
