I.	Call to Order and Record of Attendance	Ms. Sima Ladjevardian, Committee Chair, called the meeting to order at 12:55 P.M. It was noted there was a quorum present, and the attendance was recorded. The meeting may be viewed online through the Harris Health website: http://harrishealthtx.swagit.com/live .									
II.	Approval of the Minutes of the Previous Meeting	Governance Committee Meeting – June 13, 2025	Moved by Ms. Libby Viera-Bland, seconded by Ms. Sima Ladjevardian, and unanimously approved the minutes of the June 13, 2025, meeting. Motion carried.								
III.	Discussion Regarding Board Member Attendance and Participation in Board Meetings	Ms. Sara Thomas, Chief Legal Officer for the Harris County Attorney's Office, opened the discussion by emphasizing the importance of board member attendance and active participation. She reminded the board that, in accordance with the Harris Health Bylaws, each member is expected to attend at least 70% of all regularly scheduled meetings, including applicable committee meetings, within any 12-month period. In addition, board members are expected to review and evaluate all background materials included in the agenda book, which is made available through the Board's secure online portal. Ms. Thomas continued with a detailed review of quorum requirements and participation expectations. Under Texas Government Code § 551.127(b), at least five board members must be physically present to establish a quorum for board meetings. For committee meetings, the Harris Health Bylaws require that a minimum of two board members attend in person to establish a quorum. Additionally, in accordance with the Texas Government Code § 551.127(e), the presiding officer of any board or committee meeting must be physically present. Ms. Thomas also provided a review of the board's videoconferencing policy. As outlined in Harris Health Videoconferencing Policy IV, Section D, a maximum of two board members may currently participate in a meeting by videoconference. However, the Board Chair has discretion to approve additional virtual participants in extenuating circumstances. Board members who wish to attend virtually must submit a request at least seven days before the meeting, and these requests are prioritized

		based on the time and date they are received. Members must also receive written confirmation from the Board Office authorizing their remote participation. Per Texas Government Code § 551.127(j), any board member participating by videoconference must be both visible and audible to the public in order to be counted as present. The committee also addressed ongoing challenges related to attendance and	
		quorum, including instances of delayed or last-minute communication from members who are unable to attend. There was broad agreement on the importance of timely and transparent communication to maintain meeting effectiveness and board accountability. Several members expressed support for implementing structured tools and clear guidelines to help improve attendance tracking and planning.	
IV.	Technology Presentation and Discussion	Ms. Maria Cowles, Executive Vice President and Chief Strategy Officer, along with Mr. David Burnett, Administrative Director of EMS Systems, introduced Microsoft Loop, a new digital collaboration platform designed to enhance board operations. The platform enables board and committee members to record attendance, cast votes, and leave comments in a centralized online environment. Participants can update their entries while viewing the responses of others, and the platform supports real-time updates. It will also allow for tracking attendance and voting outcomes across committees. The Board Office will oversee the implementation and ensure the accuracy of the data. An active discussion followed regarding cybersecurity and guest access to the	As Presented.
		platform. Topics included account setup for external users, multi-factor authentication, and whether guest users would be able to view participant names and detailed responses. She added that the Harris Health IT team is currently conducting additional testing to address these concerns before full deployment of the platform.	
		In conclusion, the committee reiterated the need for strong accountability in attendance, transparent communication, and thoughtful integration of technology to support governance operations. Next steps include continued testing of the Microsoft Loop platform, finalization of attendance and videoconferencing procedures, and clear communication of expectations to all board and committee members.
