Ms. Sharon Brantley – Smith, Chief Assistant County Auditor, reported that Internal Audit met its FY 2026 goals for audit plan completion and post-engagement survey ratings, and provided an overview of the team's structure, healthcare audit experience, and professional certifications. Internal Audit is 75 percent completed for the FY 2025 audit plan, with 12 engagements completed and four in progress. Completed engagements included purchase order processes, cybersecurity training compliance, sterile processing follow-up, and parking cash handling. # Financial Highlights Review HARRISHEALTH

As of November 30, 2025

---

Operating income for the month ended November 30, 2025 was \$21.8 million compared to budgeted income of \$10.4 million.

Total net revenue for the month ended November 30, 2025 of \$231.0 million was \$3.6 million or 1.5% less than budget. Net patient revenue was \$7.8 million less than budget while Medicaid Supplement Programs was \$5.5 million more than budget.

As of November 30, 2025, total expenses of \$209.2 million were \$15.0 million or 6.7% less than budget. Total labor costs and supply expense were \$8.3 million and \$5.9 million, respectively, less than budget. The decrease is due to the timing of strategic initiatives' implementation as well as the decrease in patient volumes experienced across the system for the month of November.

For the month ended November 30, 2025, total patient days and average daily census were 5.2% less than budget. Inpatient case mix index, a measure of patient acuity, was 3.5% lower than budget while length of stay was 2.7% higher than budget. Emergency room visits were 6.0% less than budget. Total clinic visits, including telehealth, were 0.1% higher compared to budget. Births were 27.1% less than budget.

Total cash receipts for the month were \$128.1 million. The System has \$1,371.0 million in unrestricted cash, cash equivalents and investments, representing 202.1 days cash on hand. Days cash on hand continues to be impacted by reimbursement from the Series 2025 bond totaling \$503.2 million as of November 30, 2025, for capital expenditures tied to the Strategic Capital Plan. The remainder of the \$840 million issuance is recorded as an asset limited as to use within the balance sheet. The corresponding debt is shown within the long-term debt portion of the balance sheet.

Harris Health has \$148.4 million in net accounts receivable, representing 65.5 days of outstanding patient accounts receivable at November 30, 2025. The November balance sheet reflects a combined net receivable position of \$117.3 million under the various Medicaid Supplemental programs. The current portion of ad valorem taxes receivable is \$1,232.6 million, which is offset by ad valorem tax collections as received. Accounts payable and accrued liabilities include \$1,030.1 million in deferred ad valorem tax revenues that are released as ad valorem tax revenue is recognized. As of November 30, 2025, \$0.1 million in ad valorem tax collections were received and \$101.4 million in current ad valorem tax revenue was recognized.

A majority were uninsured as they were patients experiencing homelessness and as Texas has not expanded Medicaid eligibility. The decrease in patients and visits in 2024 was related to shortage of staffing and breakdown of mobile units. The sliding fee scale does not seem to have been a barrier to care. A waiver of fees is made available. With most clients at or below 100% of the FPL and with a waiver process, the program does not foresee the fees as creating a barrier to care.


