## **PROJECT SPOTLIGHT**

#### The University of Texas Health Science Center

This project establishes the first UT Physicians Community Health and Wellness Center (CHWC) in a low income and medically underserved area in our region. The overarching goal of the CHWC is to provide culturally relevant and affordable healthcare using Advanced Care Practitioners with a focus on preventive health and wellness. The center is well integrated with existing resources in the community. Community leaders and stakeholders were included in identifying gaps and priority services needed, as well as in the planning and implementation of support services.

UT Physicians CHWC Southwest focuses on delivering preventivetype clinical services that include: periodic physicals, well child visits, immunizations, cancer screening, diabetes screening, hypertension screening, women's health screening, and mental health screening. We will also have referral services available to patients who have care needs that cannot be handled by the primary care staff in our CHWC.

In addition to clinical services, we will also provide evidence-based/ evidence-informed wellness programs such as health education (i.e., community gardening, disease self-management), physical activity programs (e.g., Zumba, tai chi), as well as disease and care support groups (e.g., behavioral health) and resources (i.e., tobacco quit line). When possible, we have collaborated with our neighboring community organizations to avoid duplicating services that are already available in the community. This center will operate using expanded hours that include evening and weekend hours.

## SECOND DY4 LEARNING COLLABORATIVE: JUNE 17, 2015

Thank you to those who attended the DY4 December Learning Collaborative at the University of Houston Hilton. Over 250 people participated in this day event! Attendees enjoyed panel discussions on the 1115 Wavier, The Texas 84th Legislature and Medicaid Expansion. Other presentations included connecting the dots between DSRIP and Managed Care Organizations. Dr. Charles Begley of UTSPH, presented on the region's Category 3 selected measures showing the potential healthcare impact the outcomes would have on the region. Additionally, Dr. Lee Revere, of UTSPH and John Cramer of Memorial Hermann, educated the audience on several methods to analyze project performance. They then led a tabletop activity during which groups applied data analysis methods to measure performance and identify opportunities for improvements. The conference provided opportunities for stakeholders to learn about the region's projects through networking and 26 project showcase posters. #### **Collaboration Best Practices Cohort**

The Collaboration Best practices Cohort is focused on common elements across best practices and process implementation/improvements as it relates to building collaborative partnership amongst providers and the community. The Cohort kicked off on February 13, 2015 in response to common challenges experienced by providers when collaborating with the same regional providers,

primarily community clinics and FQHCs. Members were surveyed to better assess the scope of current collaborative efforts, points of contact and the process for project implementation. Survey results revealed that while many performing providers were collaborating with the same organizations, there were significant variations in both the points of contact and the level of success experienced in implementing projects.

The Cohort aims to achieve a better understanding of how community clinics operate and the challenges they face. Cohort leaders are currently working on an opportunity for the Cohort to open dialogue with the Harris County Healthcare Alliance members to share data regarding our survey results and wavier related projects in hopes of establishing a process for partnering with community organizations to ensure more effective health care delivery. We look forward to continued collaboration from all stakeholders across the Region as we seek to build relationships among performing providers to ensure that patients and clients are provided with the valuable services our DSRIP projects offer.
