Objectives of the Model:

The objectives of the RHP Plan Update Anchor form are to facilitate the aggregation and compilation of the provider forms completed by the participating providers in the Anchor's region.

Steps for using the Tool:

1. Indicate your RHP. When you do so, additional tabs may open up. You may begin filling out the Anchor-only entries in this form after selecting the RHP, but it is suggested that you compile the provider forms first before filling out Anchor-only entries. If you need to change your RHP, it is recommended that you close the template and start over.



2. Place all of the provider forms that you would like to import/capture into a single folder on your network or hard drive. For efficiency purposes, it is recommended to make copies of the submissions on your local hard drive and point this model to that local folder.

3. Run the applicable consolidation. The "Compile Valuation Data" macro should only be used for initial redistribution of RHP funds. Description: This macro will erase information currently summarized in the Anchor Form, if any, and will add data from the templates located at the folder path specified in Step 2.

Additional Notes for the User:

If, upon review of the provider form submissions, it is determined that a particular provider form will need to be resubmitted, remove or update the file from the folder path above and rerun the consolidation. This is the best way to ensure that the Anchor inputs will be saved and that the proper updated data will be consolidated.

The Region 3 Anchor completed an update to the community needs assessment (CNA) August 2017. Since then, there have been no significant changes to the community needs information on a regional scale. In order to verify whether an update was needed, the Anchor reviewed data sources used in the 2017 RHP 3 Community Needs Assessment, primarily the County Health Rankings data. We found that most of the public health outcomes data was updated at most by two years, with the most recent data being between 2012 and 2015. Moreover, the data had not changed significantly by county-level or in such a way that reflected a change in priorities or needs for Region 3. Additionally, input from Anchors in other regions revealed similar experiences with data and ultimately led the Region 3 Anchor to forgo updating the CNA for DY9-10.

To publicize the meeting before it occurred, the RHP3 Anchor sent three email announcements with a meeting registration link. The first we sent to our entire 1115 Waiver contact list on 11/6/19. We followed it with an email to just our main DSRIP contacts on 11/12/19. On 11/15/19, we again emailed our entire 1115 Waiver contact list with the webinar registration link, a link to our website where we posted all 25 provider plans and the Anchor template, and guidance for how stakeholders should submit input to us outside of the actual webinar (via email).

The Anchor did not receive any comments via email or during the stakeholder engagement webinar. However, we were notified by a fellow Anchor that there is a difference in the Taxpayer Identification Number (TIN) between DSRIP and UC IGT entities, leading to us to add the Harris County Hospital District (LPPF) as a new UC-Only IGT Entity. Additionally, the Anchor eliminated one of the overarching activities in the DY9-10 Learning Collaborative Plan due to a logical change of priorities identified during a Learning Collaborative Brainstorm discussion with stakeholders, resulting in a total of three identified activities.
