I.	Call to Order and Record of Attendance	Dr. Andrea Caracostis, Chair, called the meeting to order at 1:01 p.m. It was noted that a quorum was present and the attendance was recorded. Dr. Caracostis announced that while some board members are in the room, others will participate by videoconference as permissible by state law and the Harris Health Videoconferencing Policy. Only participants scheduled to speak have been provided dial in information for the meeting. 11.	Approval of the Minutes of Previous Meeting Quality Committee Meeting – October 4, 2022		Moved by Dr. Arthur Bracey, seconded by Ms. Alicia Reyes, and unanimously approved the minutes of the previous meeting.
111.	Harris Health Safety Message: Clostridium Difficile (C-diff)	Dr. Steven Brass, Executive Vice President & Chief Medical Executive, delivered a Minute for Medicine video series centered on Clostridium Difficile (C-diff). He stated that Harris Health's C-diff rates fall below the national benchmarks. He shared that he is very proud of the great work being done to reduce the C-diff rates, including the Systems' antivirus stewardship, infectious disease practices and several of the clinical order sets put into place. IV. Presentation and Discussion Regarding Emergency Care Research Institute (ECRI) Top 10 Patient Safety Concerns 2022	Ms. Debbi Garbade, Vice President, Patient Safety and Risk Management, delivered a presentation regarding Emergency Care Research Institute (ECRI) Top 10 Patient Safety Concerns 2022. She stated that ECRI is the global authority on patient safety and technology, which houses the largest database of patient safety event data. She also noted that ECRI performs forensic equipment investigations as well as independent medical device evaluations. Ms. Garbade shared that Harris Health applied a Failure Modes and Effects Analysis (FMEA) for the use in continuous improvement. ECRI's top 10 patient safety concerns include: 1) staffing shortages, 2) COVID-19 effects on healthcare workers' mental health, 3) Bias and racism in addressing patient safety, 4)Vaccine coverage gaps and errors, 5) Cognitive biases and diagnostic error, 6) Non-ventilator healthcare-associated pneumonia, 7) Human factors in operationalizing telehealth, 8) International supply chain disruptions, 9) Products subject to emergency use authorization, and 10) Telemetry monitoring. Ms. Garbade provided a high-level overview of ECRI's top 10 patient safety concerns. Dr. Arthur Bracey inquired how this information is used to stimulate reporting. Dr. Brass stated that it's a culture of safety. He shared that as Harris Health moves towards its journey towards a high-reliability organization (HRO), leadership encourages speaking up for safety and event report. Additionally, Dr. Brass highlighted the Good Catch Award Program, which recognizes individuals who speak up for safety issues, serves as a tracking metrics and makes those numbers known throughout the organization. V. Presentation and Discussion Regarding Gastrointestinal Service Line	Dr. Brooks Cash, Interim Medical Director, Gastroenterology, University of Texas Health Science Center at Houston (UTHealth), delivered a presentation regarding Gastrointestinal (GI) Service Line. Dr. Cash and Dr. R. J. Sealock, GI, Baylor College of Medicine (BCM), shared several noteworthy awards and accomplishments received by the GI physicians at Lyndon B. Johnson and Ben Taub Hospitals. Dr. Cash provided an outline of the GI service line year in review. Ms. Amineh Kostov, Vice President, System Service Lines, touched upon the GI service line measures as well as the academic year 2023 goals. Dr. Caracostis inquired regarding the volume of colonoscopy procedures. Dr. Esmaeil Porsa, President & Chief Executive Officer, reported approximately 3,000 outstanding colonoscopies.	As Presented.

		He mentioned that upon the re-opening of the Quentin Mease facility, Harris Health will see a reduction in the number of outstanding colonoscopies and going forward, will better manage the colonoscopy backlogs. Ms. Alicia Reyes expressed her thanks to the GI staff, physicians, and committee members for their hard work and dedication on performing a system-wide assessment. Dr. Bracey inquired regarding the staffing needs. Dr. Jackie Brock, Executive Vice President & Chief Nursing Executive, stated that Harris Health has the appropriate physicians allocated. She shared that there are full – time equivalents (FTE) available, however, Harris Health struggles to get them and keep them filled. Dr. Brock stated that there are ongoing efforts and they have been making ground. A copy of the presentation is available in the permanent record.

Consideration of Approval of the 2023 – 2024 Harris Health Utilization Review Plan	Dr. Jason Chung, Associate Chief Medical Officer & Senior Vice President, Medical Affairs and Utilization, presented the 2023 – 2024 Harris Health Utilization Review (UR) Plan. Having a High-reliability Organization's Mindset

High-reliability Organizations (HROs) are those that successfully complete their missions despite massive complexity and high risk. Examples include the Federal Aviation Administration's Air Traffic Control system, aircraft carriers, and nuclear power plants. In each case, even a minor error could have catastrophic consequences. Yet, adverse outcomes in these organizations are rare. The key components of High Reliability Organizations (HROs), including leadership, a safety-focused culture, and a dedication to continuous learning and improvement.

Call the Rapid Response Team for:

- Acute change in pulse, blood pressure, respiratory status or mental status
- Acute or significant bleeding
- Signs and symptoms of stroke
- New, repeated or prolonged seizures
- New onset chest pain
- Failure to respond to treatment for an acute symptom or problem, such as chest pain refractory to nitroglycerine
- Staff, patient and/or family feel immediate intervention is indicated

Early RRT Activation and ICU Transfer Saves Lives.



Request ICU Admission* for:

- Critically ill, unstable patients in need of intensive treatment and monitoring that cannot be done outside the ICU
- Patients who require intensive monitoring and may potentially need immediate interventions

*ICU admission decisions may be based on several models using prioritization, diagnosis, and objective parameters to place critically ill patients in the appropriate ICU units.




