

l.	Call to Order and Record of Attendance	Dr. Andrea Caracostis, Chair, called the meeting to order at 11:33 a.m. It was noted that a quorum was present and the attendance was recorded. Dr. Caracostis announced that only participants scheduled to speak have been provided dial in information for the meeting. II.	Approval of the Minutes of Previous Meeting Joint Conference Committee Meeting – November 10, 2022		Moved by Dr. Arthur Bracey, seconded by Ms. Alicia Reyes, and unanimously approved the minutes of the previous meeting.
III.	Medical Staff Engagement		
	A. Strengthening Medical Staff Involvement:     Operations and Service Lines     1. Harris Health Service Line Strategy Update	Mr. Louis Smith, Senior Executive Vice President & Chief Operating Officer, introduced Ms. Amineh Kostov, Vice President, System Service Lines. Ms. Kostov delivered an update on Harris Health's Service Line. She provided an overview of the 2023 goals related to the Gastrointestinal (GI), Maternal Health and Cardiology Service Lines. She addressed strategies for successful optimization and strategic planning. Ms. Kostov noted that the three (3) domains of the system service line structure are: 1) strategic direction, 2) operations, and 3) functionality. She also discussed optimizing stakeholder's time in order to maximize engagement, as well as the time demand placed on providers. Discussions ensued regarding service line efficiency and physician engagement. Dr. Kunal Sharma, Vice Chair, Medical Executive Board, shared that the service lines have made significant progress compared to previous years.	As Presented.

		He mentioned that the Cardiology Service Line and transfers for extended patients between Lyndon B. Johnson (LBJ) and Ben Taub (BT) Hospitals have never been more patient-focused and patient-centered. Dr. Sharma stated that the forum, venue and action items generated have yielded intangible results. Dr. Martha Mims, Chair, Medical Executive Board, echoed Dr. Sharma's sentiments. 	A. Goal Update Between Harris Health and UTH/BCM	Mr. Louis Smith introduced Ms. Monica Carbajal, Vice President, Contract Administration. Ms. Carbajal delivered a goal update between Harris Health, University of Texas Health Science Center - Houston (UT) and Baylor College of Medicine (BCM). She shared that BCM and UT, separately, are eligible to receive performance incentive compensation for achieving mutually agreed upon performance metrics. She shared that there are four (4) main focus areas which include: 1) Quality & Patient Safety, 2) Patient Experience, 3) Value and 4) Service Lines. There are acute and ambulatory goals for each focus area. Ms. Carbajal stated that there are several monthly performance reports and discussions held at both medical schools, as well as Service Chief Meetings and Medical Executive Committees (MEC). She stated that Harris Health is working with the medical schools to successfully close out Year 3, which ends June 30, 2023. Negotiation of Year 4 incentive goals will begin in March. Harris Health Medical Executive Board Leadership Changes	Dr. Caracostis stated that on behalf of the Joint Conference Committee, she would like to express sincere thanks and appreciation to Dr. John Foringer for his tenure as the Chair of the Medical Executive Board (MEB). Dr. Foringer has tirelessly given his time and resources while serving as Chairman of the MEB, and the Committee's achievements would not have been possible without him at the helm. Additionally, the Committee is pleased to announce that Dr. Martha Mims will now serve as the Chair of the MEB and Dr. Kunal Sharma will serve as the Vice Chair.	As Presented.

VI. Special Items		
A. Electronic Health Record and Information Technology Disaster Planning	Mr. Louis Smith introduced Mr. Jeffrey Vinson, Senior Vice President, Chief Cyber & Information Security Officer and Mr. Ron Fuschillo, Senior Vice President, Chief Information Officer. Mr. Vinson provided a brief overview of the cybersecurity threats in the healthcare industry. He noted that cybersecurity risks continue to be a top challenge for the healthcare industry and public health. He shared that within the healthcare sector, there were 602 reported breaches, compared to 289 during the same time last year, representing over a 100 percent increase and impacting over 49 million patients. He addressed the clinical and business impacts of ransomware attacks on hospitals and the System's plan for disaster recovery and business resiliency. Mr. Vinson highlighted a few information security controls such as CrowdStrike, Radware DDoS, IBM Qradar and Netskope. Mr. Fuschillo provided an overview of information technology disaster planning, disaster recovery and system backups. Harris Health's data center and connectivity strategies are a set of standards using SOC compliant data centers, advanced redundant networking, AIX and VMWare virtual cloud technology. Mr. Fuschillo explained that this strategy includes technology architecture that provides near-seamless continuity in the event of a myriad of failure scenarios. In addition, Mr. Fuschillo shared that an alternative Care Site can be deployed at a designated location within 4 to 6 hours. Dr. Steven Brass, Executive Vice President & Chief Medical Executive, shared that he had an opportunity to meet and debrief with Baylor St. Luke's IT and Medical Leadership regarding their latest Cybersecurity Event. In the near future, Harris Health will begin a process to review and perform real-time simulations using downtime procedures with medical staff for the following key documentation types:  • History & Physical and Progress Notes for each Specialty • Informed Consent Forms • Pharmacy Orders • Laboratory Orders • Laboratory Orders	As Presented.
